

OAKWOOD SCHOOL, BOARD OF GOVERNORS

Richard Geffen is Oakwood's Chair of Governors, elected by the Board of Governors to this role effective from April 2019 having previously been Vice Chair. He is also a member of Finance and General Purposes Committee and is the link Governor for Years 5 and 6. Richard was elected as a Governor in 2015. He retired as Head of Claysmore Prep School in Dorset in 2014. He spent 17 years teaching at Chichester High School for Boys and then became Deputy Head at Westbourne House School. Richard is also Chair of Goodwood Cricket and Groundsman at the cricket club.

Shirley Barnes was elected as a Governor in 2016 and is the link Governor for Years 1 and 2. Shirley is the Governor responsible for Safeguarding and sits on Education and Safeguarding Committee. She previously sat on Oakwood's Marketing Committee. Shirley is a director of Dinamiks, a Chichester-based company which specialises in performance management solutions. She also carries out charitable work.

Naomi Bartholomew was elected as a Governor as of September 2020. Naomi has joined the Education and Safeguarding Committee and is the Governor responsible for Early Years. Naomi is Headmistress of St.Catherine's Preparatory School, Bramley, Surrey. She is also an independent school (ISI) team inspector and acts as a mentor to newly appointed Headteachers for the Girls Schools Association (GSA).

Kathy Bourne is Oakwood's most recently elected Governor, joining the Board in December 2020 and she also joins Finance and General Purposes Committee. Kathy is the Executive Director of Chichester Festival Theatre and has extensive experience in the theatre industry. Kathy's daughters attended Oakwood as pupils, most recently until 2019.

Derek Bowerman has been a Governor at Oakwood since 2013 and is Chair of Buildings and Grounds Committee. He is the link Governor for Year 3. Derek is a consultant with Stride and Son, Chartered Surveyors, Estate Agents, Auctioneers and Valuers. He specialises in professional surveying services for the residential, commercial and agricultural sectors.

Lynda Butt was elected as a new Governor in March 2018 and joined Education and Safeguarding Committee, also as Governor responsible for SEND. She is the link Governor for Year 4. Lynda has worked in the SEND field for over 30 years. She has been a Headteacher of two special schools, a Special Needs adviser for Hampshire and Special Needs Officer for West Sussex.

Neville Lacey was elected as a Governor in 2016 and sits on Oakwood's Finance and General Purposes Committee. He is a Chartered Accountant with Jones Avens Chartered Accountants in Chichester. He also chairs an audit and risk committee for an insurance company. Neville's children attended Oakwood as pupils.
